 - a. Academics, Tina Morgan, Member

No update. Defer staffing updates to Candi and Julie. Candi informed group, waiting on final paperwork for last staffing position. School will be fully staffed for the first 100 students, including a counselor. Need two additional staff teacher hires for the next 100 students.

- b. Facilities, Rebecca Merrihew, Vice Chair Demo Phase A is underway. July 7th scheduled date for completion. Low voltage contractor has been selected.
- c. Marketing, Kelly Gaines, Secretary Kelly Gaines not present, Julie Carver updated group on Kelly's work on event execution on June 3rd enrollment event. The goal is to have community engagement for families to enroll students. Advertising on Spanish speaking radio station, and NSA email blast to forward to employee's families.
- d. Finance, Lisa Jones, Treasurer and Kristin Dietz from EdTec Bank balance \$764,211. Finalized the 990 tax return.
- 5) Executive Director's Report. Executive Director Julie Carver will provide the Board with information and updates regarding the following:
 - a. Outreach efforts

Continuing to work with Latino Outreach Solutions on community outreach for enrollment. Main challenge to convert application to enrollment process. Opportunity 180 recommended reaching out to schools who have had enrollment success. We did so and are working to implement new efforts. Brett and Julie presented at the NSCB Commission on Construction Education and awarded a \$109,000 grant.

Shared discussions amongst the group regarding general enrollments of schools, sentiment of families, charter lotteries, ACE's current process, etc.
